

## Frontier Credit Union Youth Celebration Terms and Conditions

### Promotion Period

The Youth Celebration will take place from March 1<sup>st</sup>, 2025 through April 30<sup>th</sup>, 2025.

### Federally Insured

Frontier Credit Union is federally insured by the NCUA.

### 1. Sweepstakes Overview: GetOut Passes Idaho

Participants have the opportunity to win two GetOut Passes for Idaho during the Youth Celebration period.

### Eligibility

- Age Requirement: Must be 18 years of age or older to enter.
- must meet membership eligibility for automatic entry
- Identification: Participants must possess a valid government-issued ID (e.g., driver's license, state ID card, or passport).

### How to Enter

- Automatic Entry: Parents of youth account holders will receive automatic entry when they complete one of the following:
  - Open a new youth account during March or April 2025.
  - Make a deposit of \$5 or more into a youth account during March or April 2025.

Mail-in Entry Option: For those who wish to enter outside of automatic entries:

- Mail your expressed interest along with your full legal name, residential address, date of birth, social security number or tax identification number, and telephone number to:

- Only one entry per adult is allowed.

### Prize Details

- Winners: Three (3) winners will be randomly selected.
- Prize: Each winner will receive two (2) GetOut Passes for Idaho, valued at approximately \$300.
- Claiming Prizes: Winners must pick up their prizes from a designated Frontier Credit Union branch as specified by the sponsor. Winners need to produce satisfactory identification upon reward collection.

#### Tax Responsibility

Winners will be responsible for any applicable taxes associated with the prize.

#### Selection of Winners

- Winners will be selected randomly within 30 days after the contest concludes.
- The odds of winning depend on the total number of entries.
- Winners will be announced via social media and Frontier Credit Union's website.

#### Prize Forfeiture

If a prize is not claimed within 30 days of the drawing, the prize will be forfeited, and an alternative winner will be selected.

### 2. Contest: Coloring Contest

The Coloring Contest will run concurrently with the Youth Celebration from March 1<sup>st</sup>, through April 30<sup>th</sup> 2025.

#### Participation

- Coloring sheets can be printed from the Frontier Credit Union website or picked up at any Frontier Credit Union branch. Coloring sheets must be returned to a Frontier Credit Union branch on or before April 30<sup>th</sup>, 2025 to be eligible for contest.
- Each branch will select one winner who will receive \$25 deposited into their youth account at Frontier Credit Union. Membership is required upon winning to collect the funds.
- Family members of Frontier Credit Union employees are not eligible for the prize.

#### Additional Information

- Stickers will be available at all branches during March and April, while supplies last.

By participating in the Sweepstakes or contests, participants agree to release and indemnify Frontier Credit Union and its representatives from all claims and causes of action related to their involvement in the Sweepstakes or contests.
