

# Frontier Credit Union Shoshone Branch Grand Opening Freezer of Meat Official Rules

**\*NO PURCHASE NECESSARY. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.\***

1. **Contest Dates/Eligibility.** Frontier Credit Union (“Sponsor”) is sponsoring the Shoshone Branch Opening Freezer of Meat Giveaway (the “Giveaway”) beginning July 14, 2025, through August 8, 2025, or after receipt of 5000 Eligible Entries (as defined below) (the “Entry Period”). Sponsor may change the dates and/or the terms of the Giveaway without prior notice. The Giveaway is open to all legal U.S. residents (“Contestant”), of the United States eighteen (18) years of age and older at the time of entry residing within the Sponsor’s Shoshone Branch field of membership. There is no purchase necessary to enter or win. A purchase will not increase a contestant’s chance of winning. The Giveaway is void where prohibited or restricted by law and is subject to all federal, state, and local laws and regulations. By participating, Contestant agrees to be bound by these Official Rules, including any modifications, and the decisions of the Sponsor, which are final. Employees or agents of Sponsor, (including members of their immediate family) or any entity associated with the sponsorship or administration of the Giveaway, are ineligible to participate.

2. **How to Enter.** Beginning July 14, 2025, and continuing until August 8, 2025, anyone who is the minimum age of eighteen (18) years of age at the time of entry and is also a United States resident, residing within Frontier Credit Union’s Shoshone Branch field of membership, can enter the Giveaway. Entries may be submitted as follows:

- a) Open a checking account with Frontier Credit Union.
  - i. In-person at the Shoshone branch located at 103 South Birch Street, Shoshone, Idaho 83352.
  - ii. Online via [frontiercreditunion.com/shoshone-go-freezer](https://frontiercreditunion.com/shoshone-go-freezer)
  - iii. speaking with a member of the Shoshone branch team.
- b) By Mail. By mailing a postcard indicating your expressing your intent to enter the **Frontier Credit Union Shoshone Branch Opening Freezer of Meat Giveaway** and providing:
  - i. your legal name,
  - ii. legal residential address including zip code,
  - iii. birth date,
  - iv. email address, and
  - v. telephone number

3. **Eligibility:** Eligible participants must be 18 years of age or older, must be legal residents of the State of Idaho, and possess a valid government-issued driver’s license or other form of photo identification, such as a state-issued ID Card or U.S. passport. The Sponsor is not responsible for lost, stolen, mutilated, destroyed, mis-delivered, illegible, incomplete or untimely entries, and such attempted entries will not be considered a part of the Giveaway. Collectively, both in-person and mailed postcard entries consistent with these Rules are referred to herein as the “Eligible Entries”.

4. **Selection of the Winner.** Only one winner will be selected. The winner will be selected by random drawing from all Eligible Entries within thirty (30) days after the Entry Period. The odds of winning are contingent upon the number of Eligible Entries received during the Entry Period. Giveaway Sponsor will attempt to contact the winner via the information provided in the winner’s entry. The name of the winner also will be announced on Sponsor’s social media pages and website. **If the prize is not claimed within 30 days after the drawing, the prize is forfeited.** Winners must produce identification satisfactory to the Giveaway Sponsor prior to being awarded any prize. Winners must collect their prize from a Frontier branch location as designated by the Sponsor.

5. **Taxes.** The winner will receive and be required to complete any applicable IRS Form W-9 and will receive an

IRS Form 1099-Misc. from the Sponsor and will be responsible to pay all taxes associated with the winnings.

**6. Conditions/Restrictions.** In exchange for the right to participate in the Giveaway, each contestant agrees to release and indemnify Sponsor, and its officers, directors, agents, parent companies, subsidiaries and employees (the "Released Parties"), from any and all claims, demands and/or causes of action of any nature or kind whatsoever, whether presently known or unknown, foreseen or unforeseen, that arise out of the participant's participation in the Giveaway. Any violation of these rules will result in disqualification. Anyone using fraudulent means to participate in and/or win the Giveaway will be subject to disqualification. Representations and Warranties.** By submitting an entry, Contestant represents, warrants, acknowledges, and agrees that Contestant: (i) has read and meets the eligibility requirements; (ii) understands that if any of the information submitted is false or incomplete, it will void the Contestant's entry to the Giveaway; and Contestant (iii) agrees to be bound by these Official Giveaway Rules.

**10. Compliance with Law.** The conduct of the Giveaway is governed by the applicable laws of the United States of America and the state of Idaho, which take precedence over any rule to the contrary herein.

**11. Rules.** Copies of these rules are free and available online on Sponsor's website.

**12. Right to Cancel, Modify or Suspend.** Sponsor reserves the right, in its sole discretion and without any resulting responsibility or liability, to cancel, modify or suspend this Giveaway or to amend these rules and regulations at any time for any reason.

**13. Association.** Facebook or Instagram or its entities have no liability or responsibility for any claim arising in connection with participation in Sponsor's Giveaway or any prize awarded. Sponsor's Giveaway are in no way sponsored by, endorsed or administered by, or associated with, Facebook or Instagram.
